1. Which of the following best describes you?

PROMPT #1: Some countries have recently implemented—or are considering implementing—new travel restrictions that would require all international visitors to test negative for COVID-19 prior to departure.

The next three questions ask about these policies.

- 8. Which best describes your view?
  - Countries should require pre-trip negative tests for all international visitors even if they have been fully vaccinated (60%)
  - Countries should require pre-trip negative tests for international visitors only if they have not been vaccinated (30%)
  - Countries should not require pre-trip negative tests for international visitors (7%)
  - Don't know/No opinion (3%)
- 9. If countries require negative COVID-19 tests for international visitors, which of the following best describes your view?
  - They should require tests to be administered within 24 hours of departure (52%)
  - They should allow tests to be administered more than 24 hours prior to departure (38%)
  - Other/Not sure (10%)
- 10. If countries require negative COVID-19 tests for international visitors, which of the following best describes your view?
  - They should require travelers to take PCR tests which are analyzed using lab equipment (35%)
  - They should allow travelers to take PCR tests or rapid antigen tests (which can be administered at home and analyzed without lab equipment) (54%)
  - Other/Not sure (12%)

PROMPT #2: Some countries require international visitors to prove they are fully vaccinated in order to travel or enter their borders. The next two questions ask about these policies.

- 11. Which of the following best describes your view?
  - Countries should allow unvaccinated international visitors (16%)
  - Countries should allow unvaccinated international visitors only if they prove they have contracted COVID-19 and fully recovered (i.e., natural immunity) (18%)
  - Countries should require international visitors to prove they are fully vaccinated (66%)
- 12. If countries require travelers or international visitors to prove they are fully vaccinated in order to travel, do you think...?
  - Travelers should only qualify as fully vaccinated if they have received a recommended booster shot (e.g., an additional dose if they had been fully vaccinated more than six months ago) (33%)
  - Travelers should qualify as fully vaccinated even if they have not received a recommended booster shot (67%)
- 13. Do you agree that more business travel would occur if airports offered rapid COVID-19 testing facilities as part of the check-in process?
